AFFIDAVIT FILED BY THE PETITIONER HEREIN

I, Pakalapati Suryanarayana Raju, s/o. Jogi Raju, aged 38 years, Business, Resident of Marredumilli, East Godavari District having temporarily came down to Hyderabad do hereby solemnly and sincerely affirms and states as follows :

1. I am the Petitioner herein and Respondent in the main petition and as such I am well acquainted with the facts of the case.
2. It is submitted that the first respondent filed M.C. 6/88 before Sub-Divisional Magistrate, Rampachodavaram claiming a Rs. 300/- as maintenance for her and Rs. 200/- for her son, that was dismissed on 31-7-1989. Against that order the respondents preferred a Revision 97/89 before IIInd Additional Sessions Judge, Rajahmundry and the same was dismissed on 25-7-1990. Against that orders the present petition is filed. While filing the present petition, they narrated in Para No. 3 it is stated that after filing the above case on the file of Sub-Divisional Magistrate, Rampachodavaram, alleged that I

continued to live with her out of that relation she became pregnant and gave birth to one male child on 12-5-1987. His name was kept as Almanath Raju. Eventhough the present petition is filed in the year 1993 they have not made second son as a Petitioner or Respondent. The petitioner filed a H.P.No. 676/93 for sending a first son for D.N.A. test for determination of the parentage. But they have not asked for second son. It is just and proper to conduct the D.N.A. test for both the children in the interest of Justice and the second son is necessary party in this case.

3. Hence for the reasons stated above it is prayed that this Hon'ble Court may be pleased to implede the 4th respondent herein as IIIrd respondent in the main Criminal Petition 549/93 and to pass such other orders as are necessary in the interest of Justice.

4. For the reasons stated above it is prayed that this Hon'ble Court may be pleased to direct the IIInd respondent to produce the IVth respondent before the authorities in Centre for Cellular and Molecular biology, Hyderabad for D.N.A. Test alongwith the IIIrd respondent and to pass such other orders as are necessary in the interest of Justice.
